2. Summary of Main Expected Results

2.1 Awareness

- Awareness at SSHRC (staff, management and governing Board) of bilingualism and official language minority questions as well as of related policy and program issues.
- Awareness at SSHRC of interdepartmental discussions and initiatives with a potential impact on research on bilingualism, on official language minority questions and on related policies and programs.

2.2 Consultation

- SSHRC programs, priorities and policies that are well-attuned to the opportunities and take into account the challenges of research on bilingualism and official languages minority questions, and related issues.

2.3 Communications

- Stakeholder and research communities that are well informed and aware of SSHRC programs and other initiatives related to research on bilingualism and official language minority questions, and related issues.
- Stakeholder and research communities and a general public that are well informed and aware of SSHRC-funded research on bilingualism and official language minority issues.

2.4 Coordination and Liaison

- Awareness at SSHRC and at interested government departments and agencies of research-related federal programs and initiatives dealing with official language minority issues and bilingualism.

2.5 Funding and Program Delivery

- SSHRC support of research on bilingualism and official language minority questions.
- SSHRC's client community is served in the language of their choice, either in English or in French.

3. Detailed Action Plan

3.1 General Information

Mandate and Governance

The Social Sciences and Humanities Research Council (SSHRC) is one of three federal granting agencies in Canada that support academic research. The Council's mandate is to promote and assist research and scholarship in the social sciences and humanities and to advise the Minister of Industry on related matters.¹ SSHRC reports to Parliament through the Minister of Industry, the Right Hon. David L. Emerson, who has certain statutory responsibilities regarding, and general oversight of, the Council.

SSHRC is governed by an independent 22-member Board, which the Governor-in-Council appoints to represent the interests of the academic, public and private sectors in all regions of Canada. The Board is chaired by SSHRC's President, who, as Chief Executive Officer, manages day-to-day affairs, has a direct relationship with stakeholders and the public, and is accountable for the administration of public funds and for delivering on the Council's mandate. Three vice-presidents and one director-general report to the President and are responsible, respectively, for Programs, Corporate Affairs, Knowledge Products and Mobilization, and Administrative Services.

Research Funding through Open, Transparent, Peer-Reviewed, National Competitions

SSHRC implements its mandate by awarding research funding after open, transparent, national competitions. The Council awards funding only after a rigorous peer-review process—the fairest and best-regarded method to allocate public funds for research—that assesses the scientific merit of the applications. In accordance with its mandate and its strict peer-review selection criteria (track record and competence of applicant; quality of the research proposal; etc.), SSHRC programs are accessible to all humanities and social sciences researchers.

SSHRC and Research on Bilingualism and Official Language Minority Questions

SSHRC programs can neither have quotas based on language nor can they privilege particular groups such as official language minority communities. Furthermore, Council programs must be national in scope and cannot be restricted to certain geographic regions. Finally, SSHRC can implement section 41 of the OLA only by supporting, through its programs, research projects on topics, which are covered by the *Act*.

The Council has two basic kinds of programs to support research and research training:

- “investigator-framed” programs, for which researcher defines the thematic area and the subject of their proposed research; and
- targeted strategic programs, for which SSHRC (and funding partner(s)) define the thematic area or mode of research, while the researcher proposes the subject.

Regarding investigator-framed programs such as *Standard Research Grants (SRG)*, *Major Collaborative Research Initiatives (MCRI)* and research training programs, SSHRC does not know in advance what subjects applicants will propose to research. Regarding strategic programs, the Council targets research on social, economic and cultural issues of key importance to Canadians after consultations with its

community and priority-setting exercises. SSHRC can target specific thematic areas such as bilingualism and official language minority questions through:

- strategic grants in accordance with its strategic priorities; or
- joint initiative programs with partners from government, the not-for-profit, public and private sector.

SSHRC's strategic priority areas usually last between three and five years and currently do include "official languages research", which is specifically targeted under the Council's *Official Languages Research and Dissemination Program*² to create new knowledge and expertise on related issues.

Within the framework outlined above, SSHRC supports, through all of its programs, research projects on many topics, including, for example, projects that address how to support and enhance the vitality of official language minority communities, and how to foster the full recognition and use of both English and French in Canada. In so doing, the Council serves its client community in both official languages and ensures the fair and equitable treatment of every application received in whichever official language.
